#### The Ewing Public Schools BOE Board Briefs: September 25th, 2017

The Ewing Township Board of Education held its monthly meeting in the Fisher Middle School media center on Monday, September 25th, 2017.

Ewing High School student ambassador to the Board of Education, Keri Capstack, updated the Board and public on events and development at EHS over the first month of school.

During his Superintendent's Report, Chief School Administrator Michael Nitti thanked the staff and school community for their work and efforts during the opening of the school year.

#### Ewing BOE Presents First "LT" Award to Top Fundraising Squad

Last school year, the Ewing Schools were faced with tragedy when staff member Lauren Tenaglia sadly and suddenly passed away in December. Lauren was a gifted and passionate teacher who was dedicated and devoted to the students of the school community.

This past year, under the leadership of District Supervisor David Hauserman, the school district started the annual "LT" Lauren Tenaglia Award. The award is dedicated in honor and memory of Lauren, and is given to the Ewing Schools team that raises the most money for Parents of Autistic Children in the Walk for a Difference Walkathon.

"Lauren was a selfless contributor to the event, giving up her valuable time to make sure that the walk was a success," Mr. Hauserman stated. "Her dedication to children and parents who needed help was awe-inspiring. This award is a small reminder of Lauren's contribution to our community."

At the September Board meeting, the first annual "LT" award was presented by BOE President Stephanie Staub and Superintendent Michael Nitti to Fisher Middle School and the team of LT's Avengers. The school and squad brought in over \$6,000 dollars while the walkathon raised over \$27,000. LT Avengers leader Roomana Kahn and Fisher's Principal Dr. Hanna accepted the award, and were joined by many members of Ms. Tenaglia's family.

"We miss Lauren tremendously," Superintendent Nitti commented. "But her legacy lives on through her students each and every day. We thank her family for sharing Lauren with us and joining us for this special event, and congratulations to Fisher and its fundraising team for its incredible effort."

Mr. Nitti then introduced the Board of Education's architect, George Duthie, who updated the Board and public on the Referendum '18 planning process.
