Good behavior and citizenship contribute greatly to how well our school operates from day to day. It is our expectation that our students will behave in a **safe** manner, take **ownership** of their actions, strive to **achieve**, and demonstrate **respect** in all settings (SOAR).

The policies outlined below reflect the most common circumstances in the usual operation of our school which demand some kind of disciplinary action. The administrator/dean of students involved will follow closely those parts of the policies which he/she can, but may have to use personal judgment in the ultimate disposition of a particular incident. All of the offenses described will be thoroughly investigated and the offender will receive Due Process prior to any action by an administrator/dean of students. This means that in all disciplinary situations, students will be given oral or written notice of all charges against him/her. If the charges are denied, an explanation of the evidence the authorities have will be provided and the student will have the opportunity to present his/her position. Ordinarily, this process will be implemented before suspension.

It should also be noted that this is a "**Guide**" and is not expected to cover all disciplinary situations which may occur. All school rules are in effect during the school day, on the student's journey to and/or from school, and at bus stops.

#### **DEFINITIONS OF TERMS USED IN THIS REGULATION**

##### **I. Adjudication Terms**

###### **General After School Detention:**

Administratively assigned detention held after school. Transportation is the responsibility of the parent/guardian.

###### **Infraction**

A notification provided to the student and/or the parent for the purposes of letting the student know the rule not followed and the proper expectation for behavior within FMS.

###### **Teacher Detentions:**

These detentions will be imposed by and conducted by a teacher. Transportation is the responsibility of the parent/guardian.

###### **In School Suspension (ISS)**

Throughout the policies described below are references to "in-school suspension" (ISS). ISS is a supervised in-house school program to which a student may be assigned while still ensuring that they participate in the academic community. Students may not participate in sports or activities while suspended.

###### **Out of School Suspension (OSS)**

The reader will also note the use of "out-of-school suspension" (OSS) in the guide. When assigned to OSS, the student may not attend school for the designated time. Students assigned to OSS may not be present in the school or on the school grounds without the approval of the Principal or his or her designee. Students may not participate in sports or activities while suspended. Students involved in serious infractions may be suspended longer than 10 days with approval of the Superintendent of Schools, until the next Board of Education meeting, at which time the Board will make a final determination.

#### **Alternative Learning Program (ALP)**

At the discretion of administration, students on five (5) to ten (10) day out of school suspensions may be assigned to ALP (Alternative Learning Program) for a portion of the suspension.

#### **Reinstatement Conference**

A mandatory meeting held with school administration, student, parents and possibly Superintendent or/and the Assistant Superintendent. The purpose is to determine the student's impending return to the team setting.

## **II. Violation Terms**

#### **Abusive/Inappropriate/Profane Language**

Language used in an abusive/offensive manner which may disrupt, demean or criticize a person or persons.

#### **Academic Dishonesty**

Cheating on examinations/assignments, plagiarizing and falsifying information as in accordance with Board Policy 5701 (Plagiarism).

#### **Alcohol/Drugs/Tobacco**

Use, possession, or distribution of alcohol/drugs/tobacco (or drug analog/lookalike) as in accordance with BOARD POLICY 5530/5533. Students will be required to participate in the school's counseling and prevention program.

#### **Assault**

Physically attacking a non-retaliating individual that could cause physical injury.

#### **Causing any Emergency Situation**

This includes false fire alarms/emergency phone calls, bomb threats, and other terroristic acts which are against the law and will be handled in accordance with local and state statutes.

#### **Combustibles**

Use/possession/distribution of fireworks, explosive articles, incendiary substances. It is against the law and will be handled in accordance with local and state statutes, and Board Policy 5131.7.

**Cutting an Assigned Area – Out of Bounds**  
Failure to report to an assigned area.

#### **Dating Violence**

Any form or pattern of physically, emotionally, verbally, or sexually abusive behavior done with the intent to threaten or control a current or former dating partner. Ref: Board Policy 5519

#### **Defiance of Authority/Blatant Insubordination/Disrespect**

Willful disobedience of a directive issued by a staff member and/or refusal to follow directions, talking back, and socially rude interactions.

#### **Dress Code**

Refer to Board Policy 5511 Dress and Grooming and the FMS agenda

#### **Electronic Devices**

Includes but not limited to cell phones, headphones, earbuds, laser pointers, electronic games, music devices, are not allowed to be used/active during school hours and must be kept out of sight during the school day.

#### **Excessive Infractions**

The accumulation of 4 or more infractions, resulting in an Office Discipline Referral (ODR)

#### **Fighting**

Physical combat between two or more students involving blows exchanged by both parties. Students who engage in a fight, physical assault, punching, kicking or any other deliberate action which could result in an injury while under the jurisdiction of the school district are considered to have participated in a fight.

#### **Forgery**

Falsifying information to misrepresent facts as expressed by teachers, staff, or parents.

#### **Gang Affiliation**

Information regarding pupils identified as having gang affiliations will be shared with local law enforcement in accordance with Board Policy 5512.02.

#### **Harassment/Intimidation/Bullying (HIB)**

Any gesture, written, verbal or physical act that has the effect of insulting or demeaning any pupil or group of pupils in such a way as to cause substantial disruption in, or substantial interference with, the orderly operation of the school. Ref: Board Policy 5512

This behavior includes but is not limited to running, yelling, play fighting, banging or kicking lockers and could result in lunch detention, parent conference or assignment to ISS.

#### **Inappropriate Behavior**

Behaviors that interfere with class/school operations and fails to comply with SOAR expectations (Soar Ownership Achievement Respect).

#### **Major School Disruption**

Any behavior which, after investigation and conference, is considered by the Administration to be a major school disruption; including but not limited to, verbal confrontations, arguing, inciting a fight/riot, or posturing to fight.

#### **Property Damage/Misuse**

Intentionally damaging or attempting to damage any school/bus/personal property in any way. The student and or parents/guardians shall be financially liable for repairs, cleaning, and/or replacements.

#### **School Bus Misbehavior**

Any behavior that is deemed unsafe/inappropriate set forth in the guidelines provided by the Ewing Public Schools transportation department.

#### **Scuffle**

Physical confrontation when no blows are exchanged.

#### **Sexually Inappropriate Behavior**

Sexual harassment, sexually explicit images/writings/actions/comments are deemed sexually inappropriate. Any consensual/nonconsensual sexual activity may constitute sexual assault and dealt with as both a criminal and school matter.

#### **Socially Inappropriate Behavior**

Any behavior that is considered a judgment upon another race, gender, ethnicity, sexual orientation, religion, etc. In addition, any behavior contrary to the established school culture and norms is considered socially inappropriate behavior.

#### **Technology Violation**

Inappropriate use of the internet and email as per Ewing Public Schools Technology Code of Conduct-Acceptable Use Policy.

#### **Theft**

Taking, stealing or unauthorized use of another's property or school property.

Any action or activity, including but not limited to, verbal/non-verbal or written threat that causes fear or threatens the well-being of a person, their family, or their property.

#### **Truancy/Leaving School Grounds**

Any absence from school which has not been authorized by parents/guardians and/or the proper school authorities.

#### **Weapons**

A weapon is defined as any instrument which is capable of inflicting injury or death to someone. Examples of items which would be considered weapons include, but are not limited to the following:

- Firearms (loaded or unloaded): BB guns, air guns, and facsimiles of firearms.
- Knives: pocket knives, switch blades, box cutters, screwdrivers, razor blades and facsimiles of knives.
- Mace or any device capable of emitting a harmful or noxious gas, vapor or liquid.
- Pipes

- a. Minor Damage that can be cleaned or easily repaired by the students, this will be done along with possible suspension (Bus, ISS/OSS). Parent notification required.
- b. Major Damage that cannot be cleaned or easily repaired by student. 3 days OSS with restitution made. Parent conference and Police notification required.
- c. Parents/guardians may be liable for applicable cost of repair for damage incurred by their student.

#### XX. School Bus Misbehavior

- a. These penalties may include a range from parent contact through bus and or school suspension.

- a. The use of the Internet is a privilege, not a right, and inappropriate use may result in a cancellation of those privileges and other disciplinary actions.
