The Parkway Elementary School and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA) (participating children), agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help children achieve the State's high standards.

This school-parent compact is in effect during school year 2023-24.

Parkway Elementary School will:

1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:
 - Engaging in a rigorous curriculum aligned to the New Jersey Student Learning Standards.
 - Receiving differentiated support and extension lessons to meet individual learning needs.
 - Attending a school environment that is safe, caring, and secure.
2. Hold parent-teacher conferences during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held in the fall (October and November 2023) and in the winter (March 2024) as needed.

Parkway Elementary School will:
